1. Introduction These Terms and Conditions outline the terms on which Radiate Arts, a registered Community Interest Company (CIC) in England and Wales (Company Number: 10986315) accepts donations. By making a donation to Radiate Arts, you agree to the following terms.

2. Donations

- a) All donations made to Radiate Arts are voluntary and non-refundable.
- b) Donations may be made as a one-off contribution or as a recurring payment, subject to the donor's preference.
- c) Radiate Arts accepts donations via bank transfer, credit/debit card, online payment platforms.

- a) Radiate Arts commits to transparency regarding the use of donated funds. Annual reports detailing income and expenditure will be made publicly available, as required by CIC regulations.

- a) Radiate Arts respects the privacy of its donors. Personal information will be collected, stored, and processed in accordance with data protection laws in the UK, including the General Data Protection Regulation (GDPR).
- b) Donor information will not be shared with third parties without explicit consent, except as required by law.

- a) Radiate Arts will acknowledge donations via email or written correspondence, unless the donor opts to remain anonymous.
- b) Public acknowledgment (e.g., on the Radiate Arts website or in project materials) will only occur with the donor's consent.
